Rule 4(1) Information

Explanatory note

This amendment, amends Schedule 1 following the States’ approval of the addition of an extra Principal Committee, namely the Committee *for* Housing, with effect from 1st July 2025, as per Rule 10(4) the Committee for Housing is required to make an update statement, to the Assembly, twice a year.

In addition, this amendment corrects the error within the policy letter relating to the meeting on 7th July 2025 which should read as follows; “Election of Committee Members” rather than “Election of Presidents”.
