The States are asked to decide whether, after consideration of the Policy Letter entitled, Dates of States' Meetings: September 2025 to August 2029, they are of the opinion: -

1. To agree that the dates on which States' Meetings shall be convened for the next political term, in the period from 1<sup>st</sup> September 2025 to 31<sup>st</sup> August 2029, shall be as set out in the table in section 3.2 of the policy letter.
2. To agree that statements under the provisions of Rules 10(4) and (5) shall be made by the Presidents and, in the case of the States of Alderney, the nominated Alderney Representative according to the following rota set out in the table in section 4.4 of the policy letter.
3. To delete Schedule 1 of the Rules of Procedure of the States of Deliberation and their Committees and replace with Schedule 1 as set out in Appendix 1 to the policy letter, to take effect on 5<sup>th</sup> May 2025.

**1 Executive Summary**

- 1.1 Rule 1.(1) of The Rules of Procedure of the States of Deliberation and their Committees ('the Rules of Procedure') provides:

*The States' Assembly & Constitution Committee shall submit, in the six months prior to a General Election, a policy letter setting out the dates on which it proposes that the States' Meeting should be convened during the States' term following a General Election, having first taken into account the school term dates and any other information which it considers relevant. The policy Letter referred to above shall also include proposals setting out the Committee or Committees whose President or Presidents will be making statements, and for the States of Alderney statement to be made by one of the Alderney Representatives, under the provisions of Rules 10(4) and (5) at each ordinary Meeting during the said period.*

- 1.2 In accordance with the above, the purpose of this Policy Letter is to propose dates that the States' Meetings should be convened from between 1<sup>st</sup> September 2025 to 31<sup>st</sup> August 2029 and the rota of statements to be given under the provisions of Rules 10(4) and (5) at each ordinary meeting during that period.

## **2 Current Arrangements**

2.1 The Committee has considered several factors when proposing the schedule for States' Meetings for the next political term:

- a) It has continued to seek to avoid scheduling States Meetings during school holidays.
- b) The previous pattern for scheduling 'special' Meetings has been retained; ensuring that special Meetings do not take place in the same week as an 'Ordinary Meeting' and commence on a Tuesday, as directed by Rule 1(2).
- c) Meetings have been scheduled on the first Wednesday in September (as well as the last of that month) to assist in managing the consideration of business after the summer recess and to reduce the gap between Meetings.
- d) For the first three years of a political term, where practicable to do so (and taking account of the school holidays) a States' Meeting has been proposed on the last Wednesday of the month (excluding August).
- e) In the final year of a political term, the frequency of States' Meetings should gradually increase, with meetings taking place on a three-weekly cycle from September to December; moving to a fortnightly cycle from January to March; and further to the Easter holidays ending, holding a Meeting each week. (covering a three-week period).

### **'Special Meetings'**

2.2 'Special Meetings' should be convened in accordance with Rule 1(2), namely the annual Budget of the States and the Committee *for* Employment & Social Security Policy Letter on the uprating of non-contributory benefits on the first Tuesday in November, and the Government Work Plan and States' Accounts in the same June meeting, starting on a Tuesday, except in General Election years.

2.3 In 2025, there is a meeting scheduled to consider the States' Accounts immediately prior to the first ordinary Meeting of the term i.e. Tuesday 10<sup>th</sup> July.

2.4 Following consultation with the Policy & Resources Committee (P&RC) the Committee acknowledge that the P & RC intend to request a revised approach to the monitoring and review of the Government Work, regarding the timetabling of 'special' Meetings.

### 3 The Proposed States' Meeting Dates for 2025 to 2029

- 3.1 The Committee is proposing a schedule in the following tables in line with the conclusions in paragraph in 2.1. The school term dates approved by the Committee *for* Education, Sport & Culture are included in the columns two and three of the tables. Appendix 2 shows these proposed dates in context of the calendar year.

**4 Proposed rota of statements**

- c) In accordance with provisions of Rule 4. (5) of the Rules of the Committee informs the States that its duties and powers include setting out the schedule of dates on which States' Meetings should be convened during the States' term, following the General Election in June 2025.
