No.132 of 2025

THE PUBLIC HIGHWAYS ("AL FRESCO" LICENCES) (FEES) REGULATIONS, 2025

In pursuance of section 5 of the Fees, Charges and Penalties (Guernsey) Law, 2007 "The Public Highways ("Al Fresco" Licences) (Fees) Regulations, 2025", made by the Committee *for the* Environment & Infrastructure on 15th December, 2025, were laid before the States.

**THE LAND PLANNING AND DEVELOPMENT (VISITOR ACCOMMODATION) (EXEMPTIONS)
REGULATIONS, 2026**

In pursuance of section 89(4) of the Land Planning and Development (Guernsey) Law, 2005, "The Land Planning and Development (Visitor Accommodation) (Exemptions) Regulations, 2026", made by the Development & Planning Authority on 14th January, 2026, were laid before the States.

In pursuance of section 17 of the Tourist Law, 1948, and all other powers enabling it in that behalf, the "Boarding Permit Fees Order, 2026", made by the Committee *for* Economic Development on 13th January, 2026, was laid before the States.

THE IMMIGRATION (BAILIWICK OF GUERNSEY) (AMENDMENT) RULES, 2026

In pursuance of section 3(2) of the Immigration Act 1971 as extended to the Bailiwick of Guernsey by the Immigration (Guernsey) Order, 1993, “The Immigration (Bailiwick of Guernsey) (Amendment) Rules, 2026”, made by the Committee *for* Home Affairs on 23rd January, 2026 were laid before the States.
