**THE CUSTOMS AND EXCISE (DYED FUEL) (RELIEF AND DRAWBACK) (GUERNSEY AND  
ALDERNEY) (AMENDMENT) ORDER, 2024**

In pursuance of section 79(1) of the Customs and Excise (General Provisions) (Bailiwick of Guernsey) Law, 1972, "The Customs and Excise (Dyed Fuel) Relief and Drawback) (Guernsey and Alderney) (Amendment) Order, 2024", made by the Committee *for* Home Affairs on 6<sup>th</sup> August, 2024, was laid before the States.

### **SUPERANNUATION FUND – ACTUARIAL VALUATION P.2024/92**

- V. After consideration of the Policy Letter entitled 'Superannuation Fund – Actuarial Valuation', dated 7 October 2024, they are of the opinion:-
1. To agree that the base level rate of the employer contributions in respect of the Combined Pool of the States of Guernsey Superannuation Fund be decreased to 7.5% of pensionable pay with effect from 1 January 2024 with additional contributions payable in respect of the special benefit groups as set out in Appendix III.
  2. To agree that the employer contribution rate for Guernsey Electricity Limited be decreased to 1.5% with effect from 1 January 2025.

## **STATES' ASSEMBLY & CONSTITUTION COMMITTEE**

### **POLLING STATIONS AND POSTAL VOTING P.2024/93**

- VI. 1. To agree that for the 2025 General Election:
- i. All polling stations shall be "super-polling stations", open to any eligible voter.
  - ii. There shall be two days of advance polling, one weekend polling day on Sunday 15<sup>th</sup> June and one weekday polling day on Tuesday 17<sup>th</sup> June.

- iii. There shall be a total of eight polling stations, with three opening on all three polling days, and the remaining five opening on the day of the General Election only.
2. To agree that a voter wishing to vote by post in the 2025 General Election must apply for a postal vote on or before Thursday, 29<sup>th</sup> May.
3. To direct the preparation of such legislation as may be necessary to give effect to the above decisions.
