**THE PLANT HEALTH (AMENDMENT OF TRANSITIONAL PROVISION) (GUERNSEY)
REGULATIONS, 2025**

In pursuance of Article 108 of Preserved Regulation (EU) 2016/2031 of the European Parliament and of the Council on protective measures against pests of plants, and all other powers enabling it in that behalf, "The Plant Health (Amendment of Transitional Provision) (Guernsey) Regulations, 2025" made by the Committee *for the* Environment & Infrastructure on 3rd September, 2025, were laid before the States.
